### Greer Recreation Association Board Meeting Minutes January 30, 2020

Location: Greer City Hall, 301 E. Poinsett St., Greer, SC 29651

### I. <u>Call to Order</u>

Wayne Yount (Chair) called to order the regular meeting of the Greer Recreation Association Board at 6:19pm on January 30, 2020 at Greer City Hall, Hall A.

### V. Approval of Minutes from Previous Meetings

### VI. Committee Reports

- a) Cultural Arts Don Poinsette Adhoc Representative
  - Greer Cultural Arts Council (GCAC) along with the Greer High School National Art Honor Society provided face painting at the City of Greer Tree Lighting on December 6. Two student board members accompanied Santa as his elves.
  - Frozen Jr. auditions were held at the Center for the Arts on November 18 and 19 with 150 children auditioning. GCAC cast 70 roles and 53 children accepted their roles. A parent meeting was held on December 2 at the Tryon Recreation Center. Rehearsals began every Monday, Tuesday, Thursday and Saturday in January at the Tryon Recreation Center. Performances will be March 6-8 and 13-15, 2020 at the J. Harley Bonds Center.

- b) **DAV** Rob Robinson Adhoc Representative
  - The Disabled American Veterans (DAV) assisted veterans in 2019 with \$14,000.81 in supplies and repairs.
  - DAV is selling engraved bricks to honor local veterans to be placed at Victor Memorial Veterans Park. The bricks will have the name, rank, awards/conflicts and years served imprinted on them. The cost is \$40 and can be obtained through the MSG Preston B. Johnson DAV Chapter 39.

- c) Tennis Red Watson Assistant Director, Parks & Recreation
  - Tennis memberships and play remains steady with a slight rise in free play and pickleball.

### VII. Departmental Update

- a) Athletics Division David Holtzclaw, Athletic Coordinator
  - Foothills Soccer Club of Greer completed fall play for the 2019 FSCG Academy season. Currently, registration for the spring 2020 recreation season is underway and the 2020 Spring FSCG Academy practices and games are being facilitated at City Stadium.
  - Greer Baseball Club completed the 2019 fall season for the recreation and Academy leagues and registration for the 2020 spring season began the first week of January for City of Greer residents and January 13 for nonresidents. Registration is set to end on February 8 with evaluations and sizing scheduled for February 18 and February 20 at Century Park.
  - Greer Girls Softball completed the 2019 fall season and are currently registering for the 2020 spring season. Staff attended the 2020 preseason meeting at Tyger River Park in Duncan, SC. League play is scheduled to begin in late March with the Diamond Dirt Class.
  - Cheer for Greer completed the 2019 fall season with a trip to the ACC Championship Game. The Cheer for Greer squads performed in front of approximately 80,000 fans at the Bank of America Stadium in Charlotte, NC. A planning committee meets once per month year round to map out all the events the squads will participate in and compete in during the fall 2020 season.
  - Wrestling Club (Tomahawks) practice is currently underway at Riverside High School where the participants practice Tuesdays and Thursdays. The club will host duals at Victor Gym on February 1 and February 15. The Greer Youth Wrestling Club continues to be one of the largest in South Carolina.
  - Youth basketball practice is currently underway at Victor Gym. Games and practices are held Monday through Saturday with standing room only availability. Approximately 1000 players and spectators arrive at Victor Gym each week to participate and watch the youth play basketball. Victor Gym continues to be one of the Parks and Recreation most used facility.
  - Stevens's ball field will be rented and utilized by high school Academy teams starting in February.

### b) Cultural Arts Division – Robin Byouk, Cultural Arts Supervisor

- The first Center for the Arts Open House with free classes was held on November 21. Classes offered were watercolor, drawing, ceramics, drama and gingerbread house creating.
- The first Gingerbread House competition was held at the Center for the Arts. The Gingerbread Jamboree was held on December 5. Sonny G gave a live performance painting, High Point Academy Honor Choir and the Byrnes Singers performed Holiday classics during the event. Gingerbread House winners were announced during the event in three categories: Adult, Youth and Child. The houses were on display for the week of December 9 at the Center for the Arts and then the display was moved to City Hall in the Wall Gallery for the week of December 16.
- The division organized the entertainment for the Christmas Tree Lighting including the amphitheater stage and promenade at City Park as well as the strolling carolers.
- The Carolina Dance Collective held adaptive dance classes on Wednesdays at the Center for the Arts.
- On January 25, an art reception was held for the opening of Jose Romero's artwork at the Center for the Arts.
- Sara Odom created the graphic artwork for multi art events and the Parks and Recreation Annual Report and Love Campaign. Sara continues programming classes for the Center for the Arts.
- Upcoming Events:
  - O Greer Cultural Arts will present "Conquering SCD: Portraits of Individuals with Sickle Cell Disease" at Greer City Hall on February 4. The exhibit by artist Daydrielane Osorio is sponsored by the Metropolitan Arts Council and the images will be donated to the Sickle Cell Foundation of Spartanburg, SC. All the images are of people with Sickle Cell.
  - The 2020 Juried Arts Show reception will be on March 25 at Greer City Hall Wall Gallery.

### c) Events Division – Robbie Davis, Events Supervisor

- The Christmas Tree Lighting was held on December 6 with one of the biggest crowds of over 2,500 people in attendance. Mayor Danner and Santa helped celebrate the lighting of the Greer Christmas Tree and Santa read the Night before Christmas. The evening offered live dance performances, marshmallow roasting, cookie decorating, face painting, free crafts/inflatables/photo booth and overall good cheer.
- Breakfast with Santa was held on December 7 with over 500 people in attendance. Attendees met Santa, enjoyed breakfast, wrote a letter to Santa and enjoy free crafts.
- The first Food Truck Rollout of 2020 was hosted at Greer City Park on January 17. Attendees enjoyed food from four different food trucks, beer from Greer Relief and music by Matt Phillips. Over 500 people were in attendance.

- Emma Hagg and Lancy Martino displayed a booth on January 25 at the Wedding Festival in Spartanburg, SC. This festival allowed the Events Division a chance to meet with potential brides in the area. The event saw over 500 in attendance.
- Since November 14 the Events Division has hosted:
  - o 64 internal events
  - o 40 rentals
  - o 4 special events
  - o 12 weddings

A total of 120 events that brought approximately 12,463 people to Greer City Park, Events Halls and the Cannon Centre.

- The Ambassadors Program Greer Station Shuttles are running; Tuesday Saturday 11am-2pm and 6pm-9pm with Sundays running from 10:30am-3pm. A total of 12,000 people have utilized the program since the January 15 start. The number of ride requests from the ride-hailing app Mytrax GPS have shown 872 requests. The shuttles are currently averaging 41 people per day.
- d) **Grounds Maintenance Division** Travis Durham, Grounds Maintenance Superintendent
  - Staff installed and removed Christmas decorations throughout Greer City Park, Trade Street, Hwy 29, Center for the Arts and pole decorations throughout City of Greer.
  - Existing chain link fencing at Victor Gym was removed to make way for the new fence installation.
  - New American, State and POW flags were installed at Veterans Park. A larger size flag was installed for the US flag.
  - WP Law performed the bi-annual check and cleaning of the Greer City Park fountains
  - Sixteen Grounds staff worked a total of 82.78 hours for the tree lighting event and 18 staff worked a total of 80.16 hours for the Greer Christmas Parade.
  - Shade structures were removed at Century Park.
  - City Stadium was prepared for the start of soccer season.
  - Hardscape Creations performed mortar repair and point-up at the large fountain in Greer City Park.
  - The annual draining and cleaning of the pond at Greer City Park was completed.
  - Travis Durham and Brian Wilson attended the South Carolina Recreation and Parks Association (SCRPA) Park Maintenance Institute in Irmo, SC on January 22-23.
  - New can lights were installed throughout the interior and exterior of the Needmore Recreation Center.
  - As warmer weather prevailed, mowing and trimming continued at the Needmore Recreation Center, Tryon Recreation Center, Veterans Park, Victor Gym and the outside areas at Stevens Field.
  - The rainfall totals for 2019 were 58.86 inches and a total increase of 11.68 inches for the year.

- e) Recreation Division Justin Miller, Recreation Supervisor
  - On January 20, the 19<sup>th</sup> Annual MLK luncheon was held. Mayor Danner described it as the "most powerful" luncheon he had ever attended.
  - Greenville County Redevelopment Association (GCRA) grants are underway; the grants assist with partial payment for our Needmore Summer Camp and the Seniors Out and Around (SOAR) computer classes.
  - New programs:
    - o Ham Radio amateur class at Victor Gym.
    - o Adaptive Pickleball partnership with Roger C. Peace at Victor Gym on Wednesdays. The first class had 25 participants.
    - Pickleball Clinics have just started with 27 participants at the three clinics. These clinics are instructional classes.
  - Eggtastic Easter event will be held on April 4 from 11am-1pm at Greer City Park as Century Park Kids Planet is under renovations.
  - Summer camp packets will be ready by mid-February and registrations for City residents will begin on March 16 and non-residents on March 23.
  - Ham Radio classes on-line traffic update is 4,582 viewers. This winter beginner, intermediate and expert classes will be offered. The Morse code had 5 students and 19,766 on-line viewers. In January 2020, they will begin a live broadcast during their classes.
  - Seniors are on the move and two trips were enjoyed today, the Tipsy Taco and the Wellborn Winery in Travels Rest. The trip to Pigeon Forge on December 12 has 81 seniors signed up with two touring buses. A new senior art class will be announced for December 3 from 2pm-4pm.
  - A new program is in the creation stage that includes baby goats and yoga.

### VIII. Financial Reports – Red Watson, Assistant Director

a) Program funds financials for the FY 19/20 are doing well. Our program registrations have been healthy and as expected with the exception of youth basketball, which had more participants than last year. We have completed or procured our winter projects paid from this fund (over seeding of rye grass on some of our fields, victor batting cage), and we have identified a new project for this year- the forestry cutting of parcels on Sunset Ave.

### b) Grants:

Bids were advertised for the outdoor restroom buildings at Victor Park and Turner Field and came back over budget. Ann Cunningham will update everyone on the status of these projects, but they are partially funded by the Land and Water Conservation Fund Grant of \$37,500 and the Parks and Recreation Development Fund Grant of \$49,910.

Greenville County Redevelopment Authority, Community Development Block Grant funds will allow for accessibility items such as pathways and parking spaces for the Kids Planet Renovation. We have now opened bids. It was \$30,000 more than we originally requested, so we will request that the additional amount be funded as well.

# City of Greer Parks & Recreation Department Monthly Report for January 2020



Tomahawk Youth Wrestling practices were held at Riverside High School on Tuesday and Thursday nights throughout the month of January.

### "Creating Community through People, Parks and Programs"

### **Department Projects**

- Kids Planet:
  - Mandatory pre-bid meetings for Kids Planet grading, site work, and accessibility were held on January 2 with 6 companies in attendance. Bids were due on January 22, with 3 bids submitted for the grading and site work and 2 bids submitted for the accessible grading and site work. Raby Construction was the low bidder. Staff met on site with Raby Construction on January 28 to review the bids and scope of work before making a recommendation to award.
  - Bids opened for tree removal at Kids Planet on January 3. Work commenced on January 14, with Heatherly Tree Service of Lyman providing this service.
  - Demolition of current playground equipment continues. Rain/wet conditions have been an issue, but the project is still on schedule to complete demolition before grading and site work begins.
- Greer Golf Club:
  - On January 7, Ann Cunningham and Red Watson met with City Administrator Edward Driggers to discuss funding for the upcoming Greer Golf Club project.
  - Recreation Department staff have visited the site and met with current staff to start inventory lists for upgrades and renovations, and to begin developing job descriptions and an operating budget.
  - Meetings were held between members of the Recreation, Finance, IT, and Maintenance departments on site to start planning for transition of ownership.
- Staff are continuing to work on developing site plans for the outdoor restrooms at Turner and Victor Fields, and accessible parking area at Turner Field, and designing ADA accessible parking at Springwood Park.

# **Department Trainings**

- Exempt staff completed NIMS 300 training on January 16-17 at the Cannon Centre.
- Brian Wilson and Travis Durham attended the SCRPA Park Maintenance Institute in Irmo, SC on January 22-23.

 Cory Holtzclaw began the SC LEAD program by visiting Charleston County Parks and Recreation. The session lasted 3 days at James Island County Park.

# **Department Participation**

- On January 6, Justin Miller met with the Park Hop Committee, in partnership with Spartanburg County Parks and Recreation, to discuss Spartanburg agencies joining the group. The committee met again the following day to discuss planning for the upcoming program season.
- A meeting was held at City Hall on January 29 to discuss the 2020 International Festival in April.

# **Division Highlights**

The Parks and Recreation Department had their annual inspection on January 21.

### Athletics:

- Spring youth baseball and girls' softball registration, which opened on December 23, continued throughout the month of January. Soccer registration began the first week of January for City residents and the second week for non-residents. Both registrations will conclude on February 8.
- The Foothills Soccer Club of Greer held a board meeting on January 7 at the Operations Center to discuss the fall season and the upcoming spring season. There were a couple of rule changes made for the spring in the U10 and U12 age divisions, and important dates were finalized including draft night, first practice, and first game.
- Division staff facilitated:
  - Foothills Soccer Club of Greer academy soccer practices and games at Greer City Stadium on Mondays, Tuesdays, Thursdays, and Saturdays. These teams compete in the South Carolina Youth Soccer Association and travel throughout the state. The spring season will continue through mid-May.
  - Youth basketball practices and games at Victor Gym Mondays through Saturdays for 8U, 10U, and 12U age divisions. Games began on January 6 for all three age divisions. The 8U and 10U teams play all league games at Victor Gym, while the 12U division travels to Mauldin Sports Center for league games. The season will continue through late February.
  - Tomahawk Youth Wrestling practices at Riverside High School on Tuesday and Thursday nights.
    The wrestlers are participating in matches throughout the Upstate. An inter-squad duel was held
    at Victor Gym on January 4. Two additional duels with Boiling Springs and Dorman will be held at
    Victor Gym on February 1 and 15.

### Recreation:

- The 19 annual Dr. Martin Luther King Jr. Day Luncheon was held on January 20 with a sold out crowd of 315 ticketholders in attendance. Brandon Brown and Marvin Miller, the 2020 Samaritan Award Winners, were recognized during this popular event.
- There were two Greenville County Sherriff primary elections in the month of January, facilitated by Recreation Division staff at the Needmore Recreation Center. There were a total of 374 voters.
- Ham Radio Amateur classes began meeting on January 14 at Victor Gym.
- Pickleball coaching clinics started in January with 32 participants per session. Adaptive Pickleball also held two sessions this month with 34 participants.
- The Recreation Division continued to facilitate the following programs:
  - Senior Action Needmore Recreation Center, Mondays-Fridays (200 participants monthly)
  - Never Alone Tryon Recreation Center, Tuesdays (80 participants monthly)
  - Cutlery Club Tryon Recreation Center (20 participants monthly)
  - Artifacts Club Tryon Recreation Center (74 participants monthly)
  - Pickleball Victor Gym, Tuesdays and Thursdays (215 participants monthly)
- SOAR (Seniors Out and ARound)
  - There were 4 Line Dance Classes this month on January 8, 15, 22, and 29 with an average of 34 seniors in attendance.
  - Bingo was held on January 9 and 30 with 27 members in attendance each day.
  - On January 23, SOAR had 10 seniors take a tour of the BMW factory. They got the chance to see
    the process of building one of these fantastic cars and to learn the history behind BMW.


- The monthly Movie Day was held on January 27 with 28 seniors in attendance to watch the movie "Judy", based on the life of Judy Garland.
- The month concluded with a Lunch Bunch visit to Southern Growl on January 31. There were 30 seniors in attendance to enjoy great food and fellowship that day.

- The Center for the Arts hosted the opening reception for local artist Jose Romero, with 99 people in attendance. He sold 4 pieces of artwork during the event.
- The Greer Children's Theatre started rehearsals in January for Frozen Jr. at the Tryon Recreation Center on Monday, Tuesday, and Thursday evenings and Saturdays during the day. Performances will be held at the J. Harley Bonds Career Center in March.
- Robin Byouk attended the Junior Theatre Festival in Atlanta on January 17-19.
- On January 23, the Arts Division met with International Ballet to discuss a possible partnership at the Center for the Arts.
- The Center for the Arts hosted several art classes throughout the month, including 2 watercolor classes and a ceramics class.
- Robin met with the Family Festival committee to discuss upgrading the quality of artist participation in the event.
- On January 29, the Arts Division met with all of the Artists in Residence to discuss the upcoming calendar and events for Center for the Arts.
- Robin and Evan Hamlin, the director for Godspell, interviewed all Greer Children's Theatre Student Board members to decide who will be in which director position for this production.

### Events:

 The Events Division hosted 51 events, at which an estimated 3,627 guests visited the City of Greer Events Center.



- The first Food Truck Rollout of 2020 was held on January 17. Attendees were able to enjoy food from 4 different food trucks, beer from Greer Relief, and live music by Matt Phillips.
- Emma Hagg and Lancy Martino set up a booth at The Wedding Festival in Spartanburg on January 25.
   This festival allowed the Events Division a chance to meet with future brides in the area. About 500 people attended this event.


### Cultural Arts:

# **Department Projects**

- Staff completed Funds 10 and 11 Fiscal Year 20/21 budgets. Fund 09, 23, 50 and 57 are being developed and reviewed.
- Kids Planet:

  - The average attendance for the month was 27.


